




H		Slat Roll	2 pcs
I		Allen Key	1 pc
J		Short Bolts (15mm)	12 pcs
K		Long Bolts (40mm)	3 pcs
L		Ratchet Tool	1 pc


1 Attach side rail brackets (F, G) to the headboard (A) and footboard (B) with 15mm bolts (J) and the ratchet tool (L).




- 2** Fasten side rails (C) to the side rail brackets (F, G) on the headboard (A) and footboard (B) by sliding preassembled 15mm bolts into the side rail bracket openings. Tighten with the ratchet tool (L).




- 3** Connect center support bar (D) to the headboard (A) and footboard (B) using 15mm bolts (J) and the ratchet tool (L).



4 Fasten each center support leg (E) to the center support bar (D) using 40mm bolts (K) and the ratchet tool (L).



5 Position first slat roll (H) at the head of the bed frame. Unroll each slat and attach to black straps on the side rails (C). Repeat with the second slat roll at the foot of the bed frame.



NOTE: Firmly press the slat roll onto the black straps.
