- 4. CUSHION CONSTRUCTION LIMITED THREE (3) YEAR WARRANTY OUR FOAM CORES ARE WARRANTIED TO THE ORIGINAL PURCHASER AGAINST MANUFACTURING DEFECTS IN MATERIAL OR WORKMANSHIP FOR THREE (3) YEARS UNDER
