30" SLIDE-IN RANGES

If your countertop cut-out depth is less than 24" and you are not satisfied with the fit of your new Whirlpool brand 30" slide-in range, Whirlpool will provide **up to \$100** toward the cost of professionally modifying the depth of your countertop cut-out.
