**Undercounter Refrigeration Produced 1/4/21 or later (HP, HH HA, & HC Series Models)**

**SIX-YEAR PARTS & LABOR WARRANTY\***

For undercounter refrigeration, purchased 1/4/2021 or later. PERLICK warrants to the original purchaser of every new PERLICK refrigerated unit, the cabinet and all parts thereof, to be free from defects in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with the Use & Care Guide supplied with each PERLICK unit. PERLICK'S obligation under this warranty is limited to a period of six (6) years from the date of original installation or seventy-five (75) months after shipment date from PERLICK, whichever occurs first. **TWO YEAR PARTS & LABOR WARRANTY\***

For Ice Makers. PERLICK warrants to the original purchaser of every new PERLICK refrigerated unit, the cabinet and all parts thereof, to be free from defects in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with the Use & Care Guide supplied with each PERLICK unit. PERLICK'S obligation under this warranty is limited to a period of two (2) years from the date of original installation or twenty seven (27) months after shipment date from PERLICK, whichever occurs first.\*\* The optional Perlick drain pump carries a one year parts and labor warranty. For Column Refrigeration, PERLICK warrants to the original purchaser of every new PERLICK refrigerated unit, the cabinet and all parts thereof, to be free from defects in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with the Use & Care Guide supplied with each PERLICK unit. PERLICK'S obligation under this warranty is limited to a period of six (3) years from the date of original installation or 39 months (39) months after shipment date from PERLICK, whichever occurs first. For Column Refrigeration, Perlick warrants, to the original purchaser, its hermetically sealed system in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with Use & Care Guide supplied with each PERLICK unit. : compressor, condenser, drier, connecting tubing, evaporator, and hot gas bypass valve; to be free from defects in both material and workmanship under normal and proper use and maintenance service

for a period of twelve (6) years from the date of original installation but not to exceed twelve (6) years and three (3) months after shipment from the manufacturer, whichever occurs first.

#### **TWELVE YEAR SEALED SYSTEM WARRANTY - PARTS ONLY\***

For Column Refrigeration, Perlick warrants, to the original purchaser, its hermetically sealed system: compressor, condenser, drier, connecting tubing, evaporator, and hot gas bypass valve; to be free from defects in both material and workmanship under normal and proper use and maintenance service for a period of twelve (12) years from the date of original installation but not to exceed twelve (12) years and three (3) months after shipment from the manufacturer, whichever occurs first.

#### **ONE YEAR FULL BEVERAGE DISPENSING EQUIPMENT PARTS & LABOR WARRANTY**

For beverage dispensing equipment PERLICK warrants to the original purchaser of every new PERLICK dispensing component to be free from defects in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with the Use & Care Guide supplied with each PERLICK unit. PERLICK'S obligation under this warranty is limited to a period of one (1) year from the date of original installation or fifteen (15) months after shipment date from PERLICK, whichever occurs first. For warranty validation, be sure to properly register your unit at [www.Perlick.com](http://www.Perlick.com).

#### **ONE YEAR FULL BAR EQUIPMENT PARTS & LABOR WARRANTY**

For bar equipment PERLICK warrants to the original purchaser of every new PERLICK bar equipment piece to be free from defects in material or workmanship under normal and proper use and maintenance as specified by PERLICK and upon proper installation and start-up in accordance with the Use & Care Guide supplied with each PERLICK unit. PERLICK'S obligation under this warranty is limited to a period of one (1) year from the date of original installation or fifteen (15) months after shipment date from PERLICK, whichever occurs first. For warranty validation, be sure to properly register your unit at [www.Perlick.com](http://www.Perlick.com).

#### **TERMS APPLICABLE TO EACH WARRANTY**

Any part covered under the above warranties that is determined by PERLICK to have been defective within the time frame is limited to the repair or replacement, including labor charges, of defective parts or assemblies. The labor warranty shall include standard straight time labor charges only and reasonable travel time, as determined by PERLICK.

#### **WARRANTY CLAIMS**

All claims for labor or parts must be made directly through PERLICK. All claims should include: model number and serial number of cabinet, proof of purchase, and date of installation. In case of warranted compressor, the compressor model tag must be returned to PERLICK along with the above listed information.

PERLICK is not responsible for economic loss, profit loss; or special, indirect or consequential damages, including without limitation, losses or damages arising from food or product spoilage claims whether or not on account or refrigeration failure.
