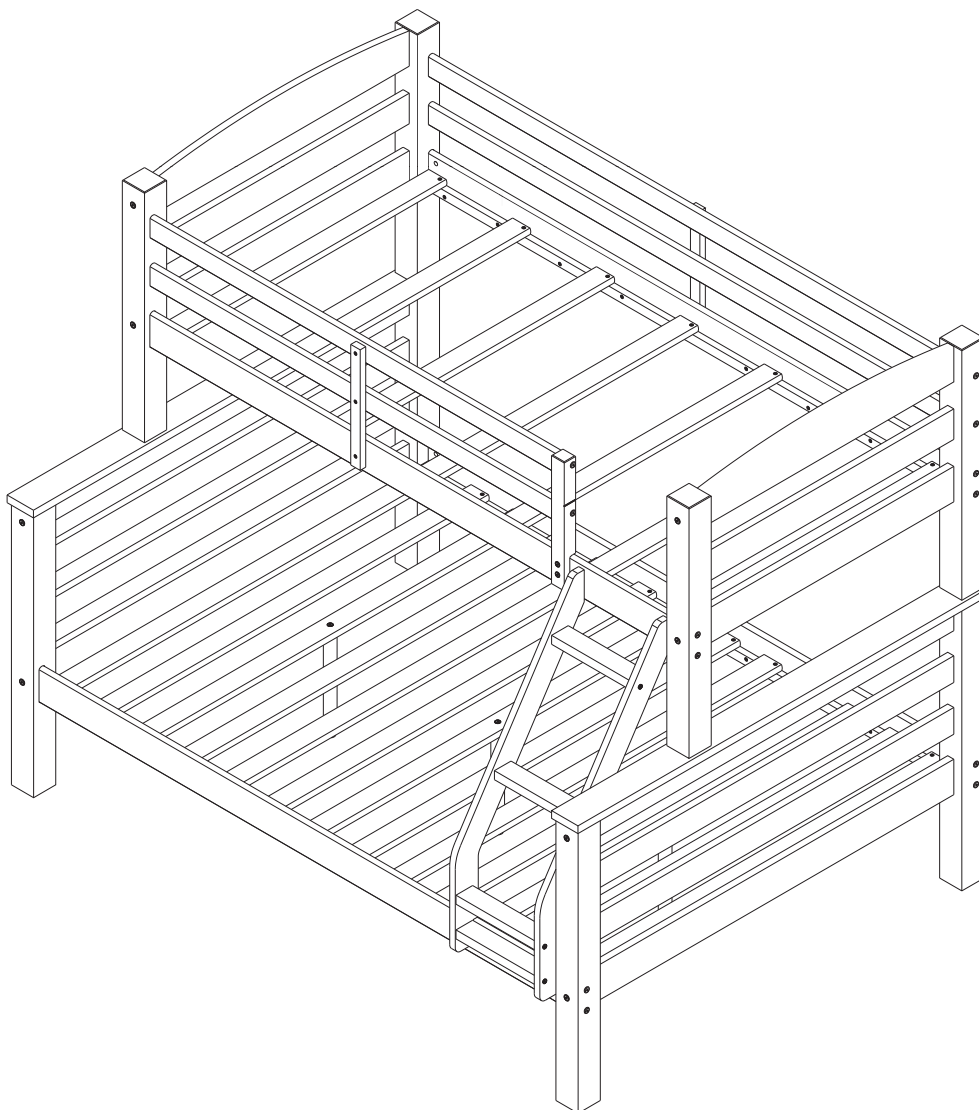


TWIN FULL BUNK BED

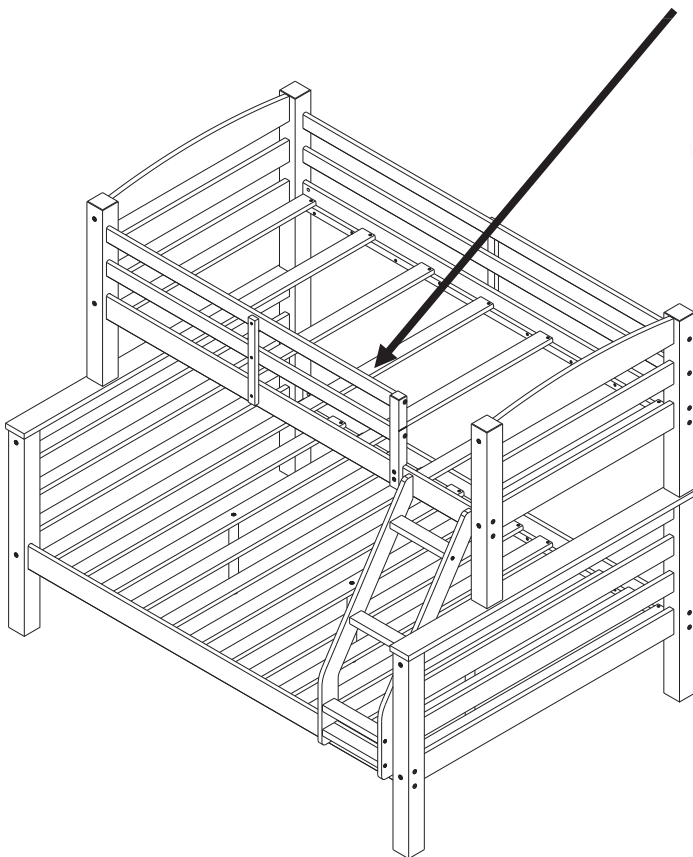
To convert the bunk bed into a full size bed and a twin bed, remove the ladder and all the guardrails. With the help of another person, remove the top bunk from the lower bunk.

- Maximum total weight is not to exceed 300 lbs. on the upper bunk.
- Periodically check and ensure that the guardrail, ladder, and other components are in the their proper position, free from damage, and that all connectors are tight.
- Do not use substitute parts. Replacement parts, including additional guardrails, may be obtained from our customer service department.
- Use of water or sleep flotation mattresses is prohibited.
