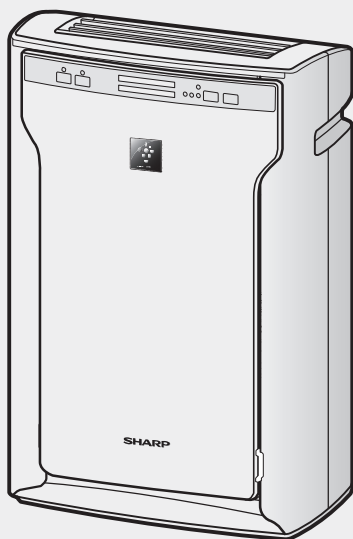

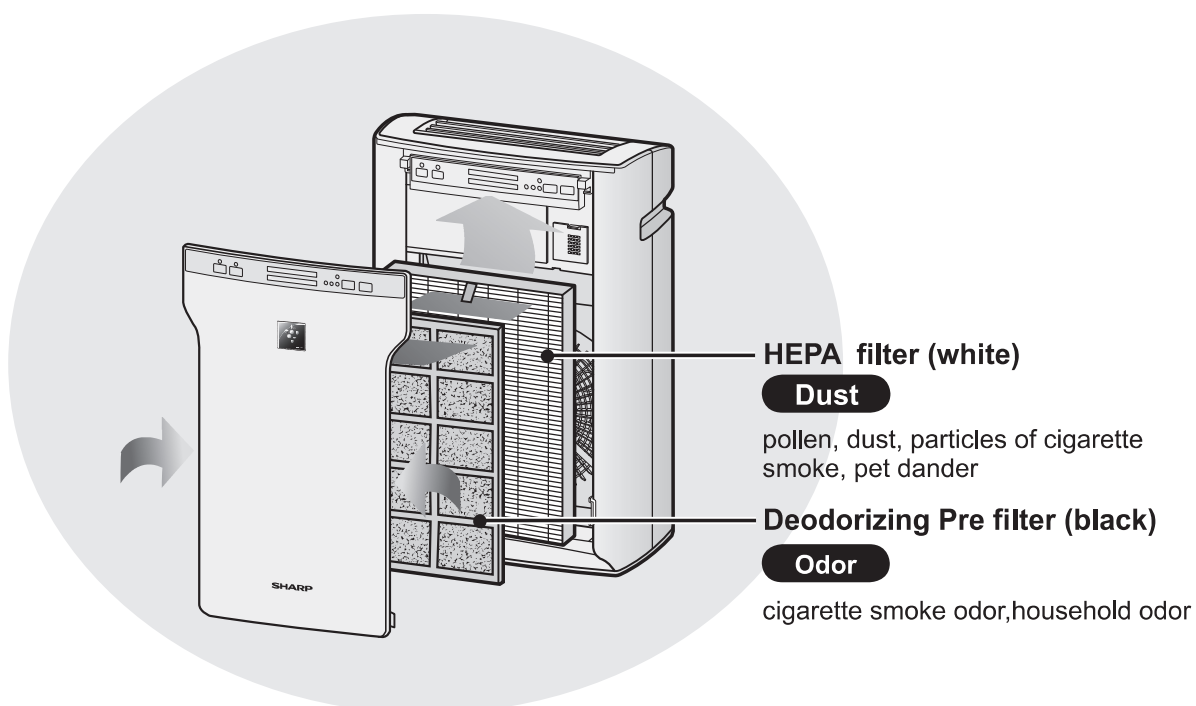
Please read before operating your new Air Purifier

Some odor ingredients absorbed by the filters may become separated and may be discharged through the air outlet and result in additional odor. Depending on the usage environment, especially when the product is used in a condition significantly more severe than household use, this odor may become strong in a shorter period than expected.

The air purifier is designed to remove air-suspended dust and odor, but not harmful gases (for example, carbon monoxide contained in cigarette smoke). If the odor sources still exist, it cannot completely remove the odor (for example, odors from construction materials and pet odors).

It is suggested to open the window a bit when you are smoking in order to facilitate ventilation.

In this case we recommend purchasing the optional replacement filter.

IMPORTANT SAFETY INSTRUCTIONS

Read all instructions before using the unit.

When using electrical appliances, basic safety precautions should be followed, including the following:

WARNING - To reduce the risk of electrical shock, fire or injury to persons:

- Connect the power plug to a dedicated electrical outlet for 120V~60Hz.
 - The air purifier has a polarized plug (one blade is wider than the other). This plug will fit in a polarized outlet only one way. If the plug does not fit into the outlet, reverse it. If it still does not fit, contact a qualified electrician or service person. Do not alter the plug in any way.
 - Do not use the unit if the power cord or plug is damaged or the connection to the wall outlet is loosened.
 - Periodically remove dust from the power plug.
 - Do not use an extension cord.
 - Do not insert fingers or any objects into the air inlet or air outlet.
 - Do not unplug by pulling on cord. To unplug, grasp the plug.
 - Do not handle plug or unit with wet hands.
 - Unplug the electrical cord before performing any maintenance.
 - Do not use the unit if the cord has been damaged. Please contact the nearest Service Center.
 - Do not use near flammable gases and material such as insecticides, fragrances, and lit cigarettes.
 - Do not use in humid place such as bathrooms.
 - Contact the nearest Sharp Approved Service Center for any problems, adjustments, or repairs.

- Do not use without filters inside the unit.
- Do not wash and reuse the filter.

It may not only make the performance worse, but also may cause electrical shock or malfunction.

- Clean the exterior with a soft cloth only.

Do not use corrosive cleansers, volatile fluids and/or detergents when cleaning the unit.
The unit surface may be damaged or cracked.

In addition, the sensor may malfunction as a result.

INSTALLATION GUIDELINES

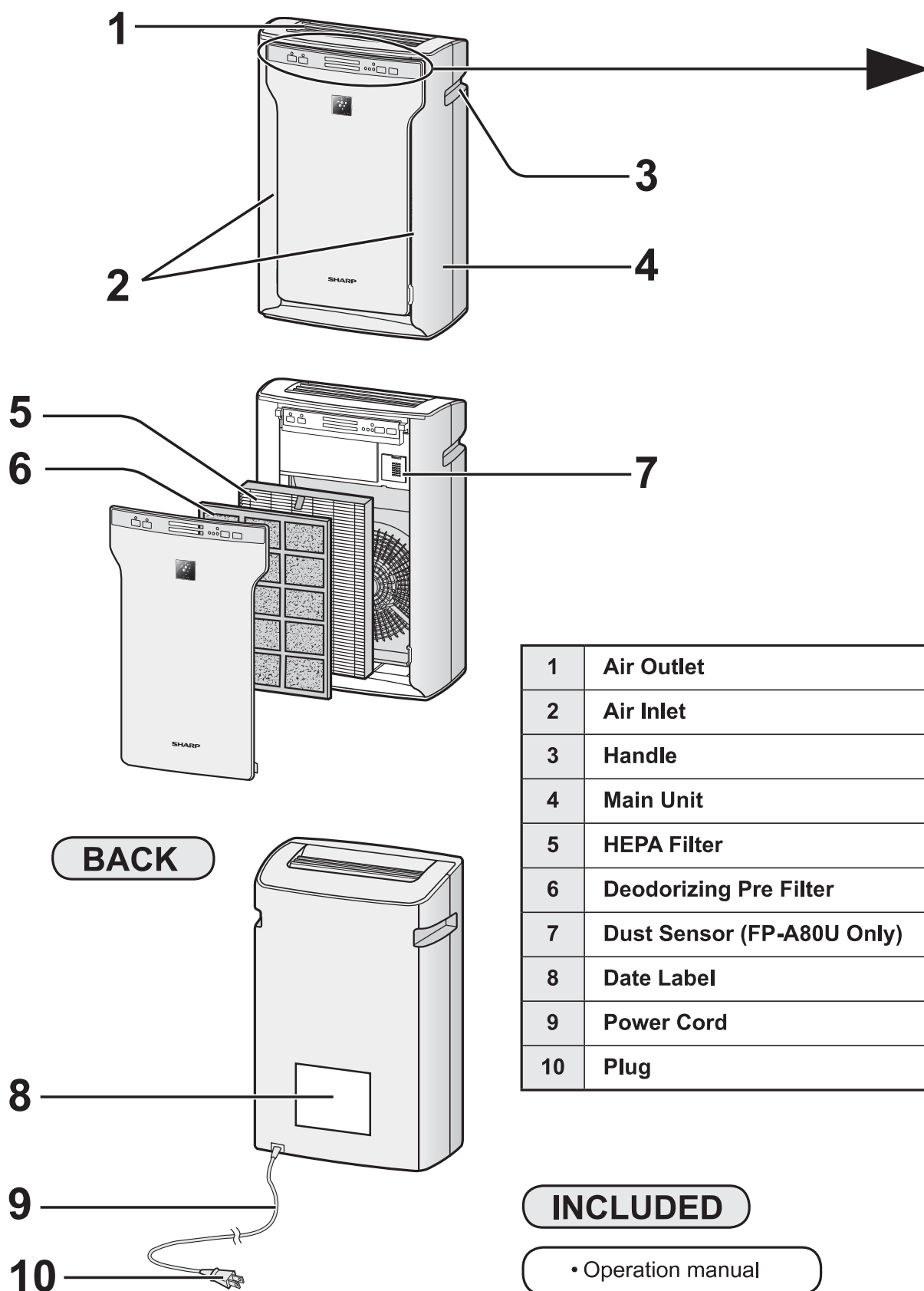
- Avoid locations where curtains, etc., come into contact with any opening.
It may become dirty or a malfunction may occur.
- Avoid locations where the unit is exposed to condensation, due to rapid temperature changes.
(If it is unavoidable please allow unit to stand for 1 hour before switching on.)
(Use under appropriate conditions between 32 - 95°F (0 - 35°C) room temperature.)
- Place on a stable surface with sufficient air circulation.
When placing the unit on a heavily carpeted area, it may cause the unit to vibrate slightly.
- Avoid use in locations where greasy or oily smoke is generated (such as in a kitchen, etc.).
The unit surface may crack or the sensor may malfunction as a result.

FILTER GUIDELINES

- Follow the instructions to handle carefully and keep maintenance.
Do not install any other type of filters.

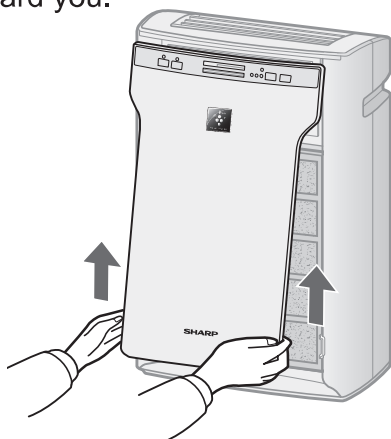
FILTER INSTALLATION

Unplug the electrical cord before performing any maintenance.

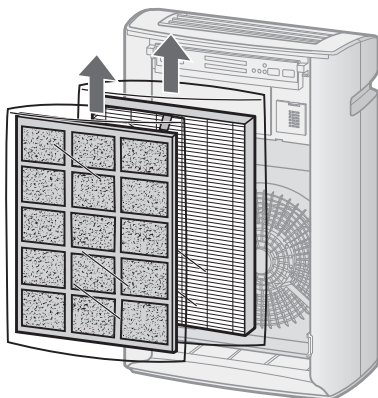
To maintain the quality of the filters, they are installed in the main unit and packed in plastic bags. Be sure to remove the filters from the plastic bags before using the unit.

1 Remove the front Panel.

Gently grip the bottom of the front panel and remove it by pulling the bottom gently toward you.

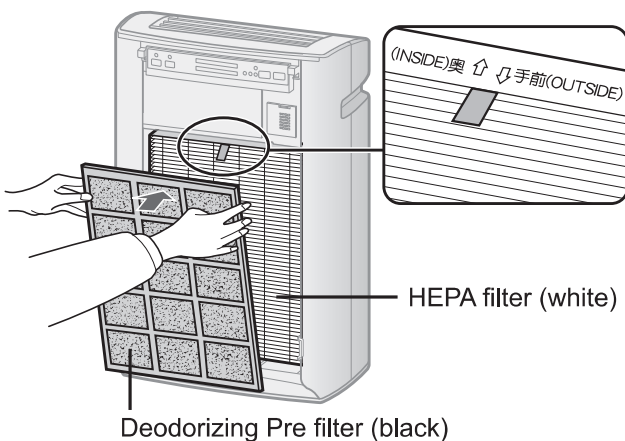


2 Remove the plastic bags.



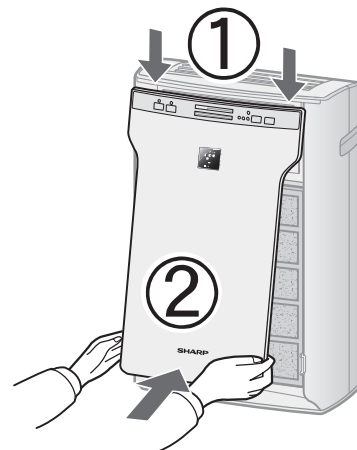
3 Place the filters accordingly.

Keep the order of filters.

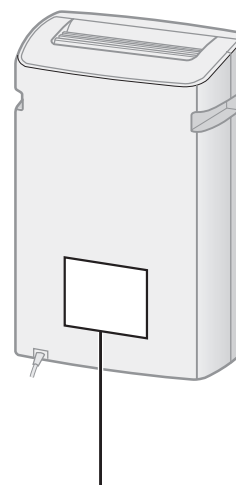


4 Fix the Front Panel.

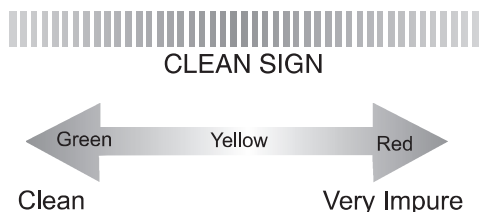

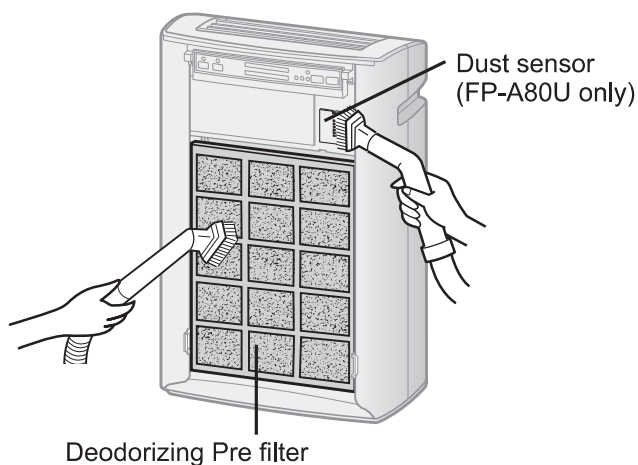

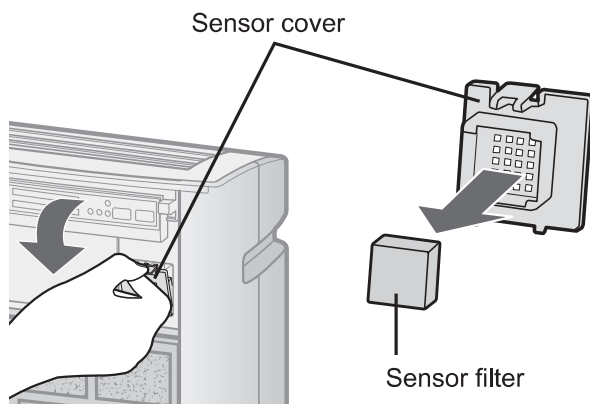

CLEANING THE FILTERS

- 1 Turn off the unit, and unplug the power cord.**
- 2 Remove the Front Panel.**
(Refer to E-8)
- 3 Clean the filter and Dust sensor.**
Gently remove dust from the filter, using a vacuum cleaner with attachment or similar tool.



Dust Sensor (FP-A80U only)



Remove the Sensor cover, and remove the dust on the Sensor filter.

If it is very dirty, wash it with water and dry it thoroughly.

CLEANING THE UNIT

Wipe with a dry, soft cloth.

For stubborn stains or dirt, use a soft cloth dampened with warm water.

Do not use volatile fluids and detergents.

Benzine, paint thinner, polishing powder, detergent ingredients etc., may damage the unit.

FILTER REPLACEMENT GUIDELINES

Filter life varies depending on the room environment, usage, and location of the unit.

If dust or odor persists, replace the filter.

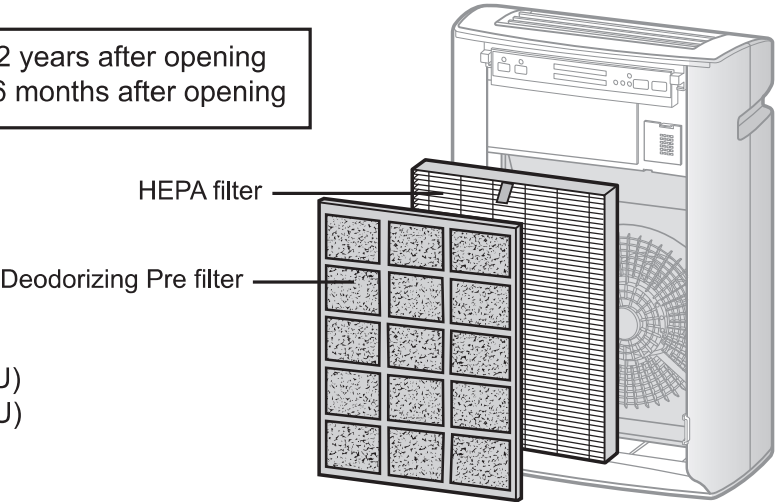

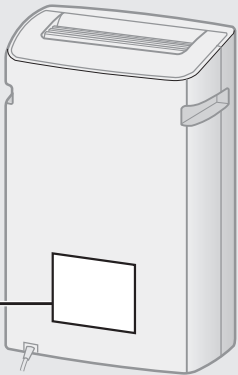

TROUBLESHOOTING

Before calling for service, please review the Troubleshooting chart below, since the problem may not be a unit malfunction.

PROBLEM	SOLUTION (not a malfunction)
The unit leaves smoke and odors in the air.	• Clean or replace the filters as needed. (Refer to E-11) • Is the unit installed in a location that is difficult for the sensor to detect cigarette smoke? • Are the dust sensor openings blocked or clogged? (In this case, clean the openings.) (Refer to E-10)
A clicking or ticking sound is heard from the unit.	• Clicking or ticking sounds may be audible when the unit is generating ions.
A bad odor comes out of the air outlet.	• Check to see if the filters are heavily soiled. Replace the filters. (Refer to E-11) • Plasmacluster Air Purifiers may produce a slight odor. This is normal and is a result of the Plasmacluster Ions refreshing the air.
The Clean Sign is green, but there is still odor in the air.	• The air could be impure at the time the unit was plugged in. Unplug the unit, wait one minute, and plug the unit in again.
The Clean Sign illuminates yellow or red, but the air seems clean.	• Clean the dust sensor with a vacuum cleaner, as it may be blocked or clogged. (Refer to E-10)
The Clean Sign doesn't light on.	• The Light Control is selected. Press  ON/OFF for 3 seconds to turn the light on.
The Clean Sign lights change color frequently.	• The Clean Sign lights automatically change colors as impurities are detected by the dust sensor.

For energy saving, unplug the power cord when the unit is not in use.

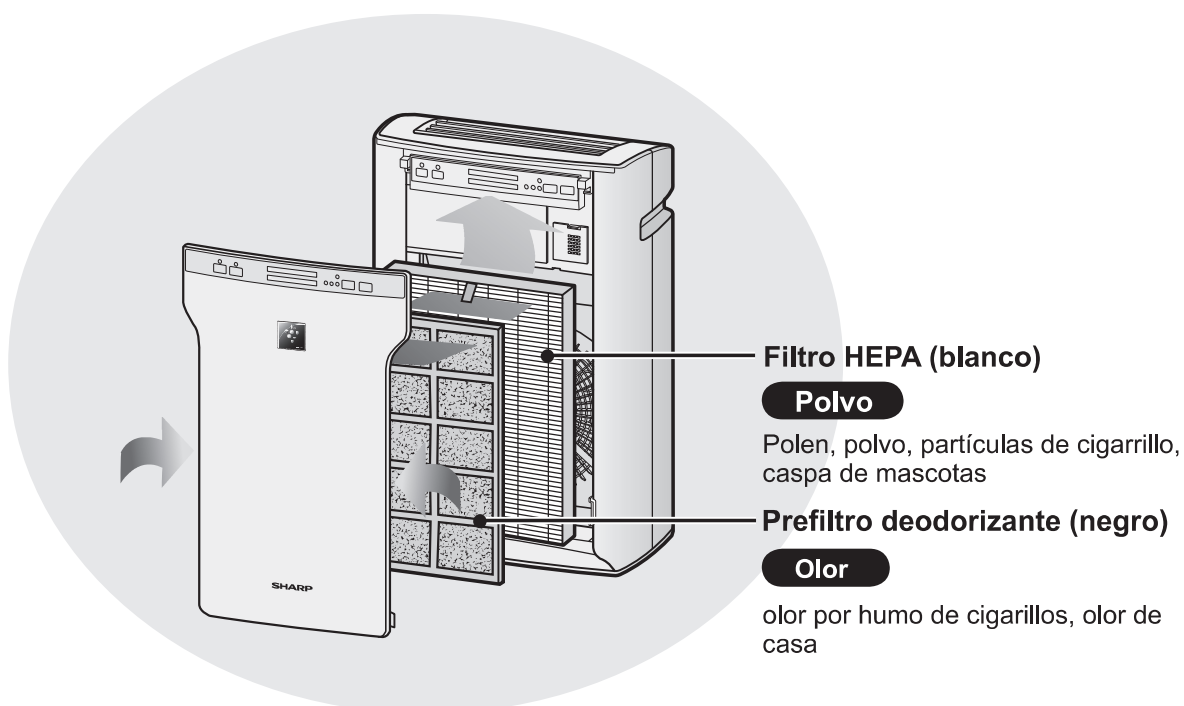

Algunos ingredientes de olor absorbidos por los filtros pueden separarse y descargarse a través de la salida de aire y resultar en un olor adicional. Dependiendo del entorno de uso, especialmente cuando el producto es utilizado en una condición significativamente más severa que un uso doméstico, este olor puede volverse fuerte en un período de tiempo más corto del esperado.

El purificador de aire está diseñado para quitar polvo y olor suspendido en el aire, pero no gases dañinos (por ejemplo, monóxido de carbono presente en el humo de cigarrillos). Si las fuentes de olor aún existen, no podrá eliminar el olor completamente (por ejemplo, olores de materiales de construcción y olores de mascotas).

Se sugiere abrir un poco la ventana cuando esté fumando, para facilitar la ventilación.

En este caso recomendamos adquirir el filtro de reemplazo opcional.
