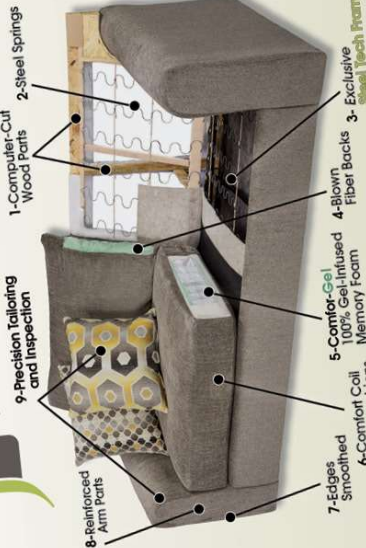




The "Inside Story" on Quality Construction
